b) Board Development

Our first round of potential board members was introduced and interviewed tonight. Our goal is to have board members on a staggered term timeline. Goal is to find one more candidate this spring.

### IX. Finance Report

a) Budget Overview

We are 75% through the year- 99% of funds have been received this year. 70.5% of our expenses have been expended.

- We are currently using the same bus company next year. Per Department of Education instructions for the month of April bus companies are paid for a percentage of bus services. Harry expressed concern about this fee being paid. Carolin stated this is only for the month of April, May procedures have not been communicated by the State.
- Additional federal funds from the CARES act will provide the school with approximately \$149,000 in additional funding due to COVIT 19. The allocations are based on a percentage of our title 1 funds. Carolin will be updated on details of this funding in the coming month. With these funds the school hopes to invest in Schoology and technology for virtual learning.
- Longevity bonus will come up next month for vote. Harry expressed concern that is was not the time to give money with the pandemic and unexpected expenses.
  - b) Enrollment

Currently enrolled for the 2020-2021 school year is 396 with documents requested for a few more incoming students. Enrollment is still on track for this time of year.

## X. Head of School's Report

- a) Status of the School
  - Remote learning /Distance learning processes have been put into place: Work is on website, printed into hardcopies upon parent request, work is dropped off and given to teachers for grading 72 hours later, amount of work and technology formats have been streamlined for parents and computers, books or other supplies have been lent out by request.
  - 2. Work does count during this time and this has been communicated to both parents and staff.
  - 3. Building is open three days a week to staff with CDC guidelines followed at all times. No students/parents are in the building.
  - 4. Heidi plans on meeting with all paras by the end of the year for professional evaluations and interviews.
