a) Budget Overview

The August Financial Statement was reviewed.

CARES Act grant funding will assist us with purchasing chromebooks, desks and supplies.

The audit is being completed now, should get report by tomorrow. Carolin will send out the final draft audit via email tomorrow. Anne made the motion to have Harry look it over for final approval, as the board representative. Sylvia 2^{nd} and all approved. This will allow us to meet the Sept 30 charter renewal deadline.

b) Enrollment

421 students expected to be enrolled in the coming days, we will not be expect to bring anymore in this school year.

XI. Head of School's Report

a) Renewal Updates:

Due on Wednesday, September 30 is document submission for charter renewal to DOE. This includes questions to answers, curriculum documents and fiscal year 2020 financial audit. We are currently applying for a five year charter renewal. The first meeting after the submission is Oct 27^{th.} Additional meetings will be held between then and the DOE December Board meeting.

b) Status of the School:

We are on week 4 and all is going well with hybrid (in person students). Technology is one of the challenges we have with remote students. We have been in contact with all families, other than 2 students who we are having issues with not responding. 45% of student population is currently remote. Our hope is that the challenges will be reduced over time and with delivery of Chromebooks at the end of Oct.

At the end of the 1st trimester families will be asked if they would like to change their current method of instruction (hybrid or remote). Buses and numbers in class will be the limitations but hope to accommodate all family requests.
