Harry Papaleo asked Annie Norman to give a synopsis of the Delaware Education Funding Summit she recently attended. It was emphasized that education funding in Delaware is outdated and that Delaware needs to move from a flat amount to a student- based model of funding.

VIII. Financial Report by Carolin Lyon

Financial Report- We are through 75% of the year and have spent 71.79% of the budget. We have received 97% of revenue. Everything is trending in the right direction and we are under budget. There are no unexpected expenses. We are trending well with grants.

Enrollment Analysis- The only grade not currently full is 4th grade, which has 6 openings. There is also no one on the waiting list for that grade. There is no one on the waiting list for Kindergarten. Leroy Travers will again reach out to parents in the ECAP program by handing out information about CCS to them when they pick up their children at dismissal. He will emphasize that there is no cost to a family for their child to attend CCS.

IX. Head of School Executive Report by Leroy Travers

The current 21st Century Grant that we have had for five years will be over at the end of the year. We applied for another 21st Century Grant, as did 19 other schools. Five schools were approved to receive a grant. CCS was denied. We can reapply for next year. The administration team will be meeting this week to discuss options for an afterschool program for next year, since this is what the 21st Century Grant funded for us.

We did receive a grant for 20 afterschool tutors for the remainder of this school year. Leroy Travers sent out an email to staff about the opportunity for them to tutor students. The possibility of amending the grant to continue tutoring into the summer was discussed.

Campus Community School is now a member of the Central Delaware Chamber of Commerce.
