VIII. Head of School's Report

a) Status of the School – "Safe Return to School Plan" We will be going full in-person with younger grades K-3 broken into smaller cohorts due

to classroom size and the need to be at least 3ft apart. Breakfast and lunch will be served in classrooms and cafeteria for 6ft apart and mask off time. Duct work and ventilation has improved due to window replacement and cleaning ducts throughout building, this is an extensive process and will be completed in classrooms before school starts. Gym and back areas will be completed this fall.

- b) Weekly Antigen testing will be for all staff and students by an outside party.
- c) All quarantine and isolation Covid rules are the same as last year.
- d) Sports are outdoors, boys' soccer and cheerleading will be offered to middle school. Field trips and special events are on based on protocols and individual cases.
- e) We are currently not requiring vaccinations but encouraging it.
- f) If covid cases spike we have hybrid A B schedule plan,
